- 2. In this regard, point wise reply to your queries is furnished hereunder-
- i) Instructions exist on rotation of officers working in sensitive posts every 2/3 years. However, these instructions are silent on rotation of officers working in non-sensitive formations. The department is strictly adhering to the instructions/guidelines available on the matter. As per the policy existing within Visakhapatnam zone officers working in Audit Commissionerate are rotated from one Commissionerate to other Commissionerate after completion of 3 years and in Customs Commissionerates is 4 years. The existing Inter Commissionerate policy deals with rotation of officers between Commissionerates of Visakhapatnam zone. No specific tenure has been prescribed for posting to the other formations of Visakhapatnam Zone.

As per CBIC's guidelines the posting in Chief Commissioner's office is treated as non-sensitive. However, it is ensured that the instructions issued from time to time on transfer/rotation are strictly adhered to.
